Sub: Furnishing of PAN, KYC details and Nomination by holders of physical securities and norms for processing investor's service request by RTA's

We trust that you and your family are safe and in good health.

The Securities and Exchange Board of India ("SEBI") vide circular no. SEBI/HO/MIRSD/ MIRSD_RTAMB/P/CIR/2021/655 dated 3rd November, 2021 ("Circular") has laid down the common and simplified norms for processing shareholder's service request by Registrar and Transfer Agents effective from 1st January, 2022. The Circular also provides for mandatory furnishing of PAN, KYC details, Nomination options; freezing of folios without valid PAN, compulsory linking of Aadhar with PAN by investors in physical form, among others. Further, SEBI vide circular no. SEBI/HO/MIRSD/MIRSD/MIRSD_RTAMB/P/CIR/2021/687 dated 14th December, 2021 has issued clarifications with respect to the Circular dated 3rd November, 2021 as above.

Freezing of Folios without PAN, KYC details and Nomination

Folios wherein any one of the abovementioned documents/details are not available on or after 1st April, 2023 shall be frozen by KFin/ the Company in terms of the aforementioned Circular. <u>The frozen folios shall be referred by KFin/the Company to the administering authority</u> <u>under the Benami Transactions (Prohibitions) Act, 1988 and/or Prevention of Money Laundering Act, 2002, if they continue to remain frozen as on</u> <u>31st December, 2025.</u>

Compulsory linking of PAN and Aadhaar by all shareholders in physical mode

From 31st March, 2022, KFin will accept only valid PAN and also verify that the PAN in the existing folios are valid; i.e. whether it is linked to the Aadhaar number of the shareholder. The folios in which PAN is not valid as on the notified cut-off date of 31st March, 2022 or any other date as may be specified by the Central Board of Direct Taxes, will be frozen.

Mandatory furnishing of PAN, KYC details and Nomination by holders of physical securities

From 1st January, 2022, the RTA shall not process any service requests or complaints received from the holder(s)/claimant(s) until PAN, KYC and Nomination documents/ details are received.
