This was intimated to the Stock Exchanges by the Company vide letter dated 16th March 2020.</p> <p>The Company had filed an appeal against the above CCI order before NCLAT and has obtained a stay.</p> <p>The Company had not created any provision in the books of account on account of this matter.</p>

The details of any change in the status and/ or any development in relation to such proceedings	<p>On 5th May 2026, the NCLAT has set aside the Order dated 16th March 2020, and remanded the matter back to the CCI for fresh hearing and consideration.</p> <p>Consequently, the penalty of INR 301.61 crore and certain behavioural directions imposed earlier on the Company have been set aside.</p>
