The ISIN, BSE Scrip code and NSE symbol for the partly paid-up shares included in this report is IN9047A01011, 890190 and GRASIMPP respectively.

The shareholding of Birla Group Holdings Private Limited ('BGHPL') in the Company has increased from 12,99,73,507 (19.10%) equity shares to 15,77,82,973 (23.18%) equity shares, pursuant to a Scheme of Amalgamation of Umang Commercial Company Private Limited, a Promoter Group of the Company and certain other entities with BGHPL. The Hon'ble National Company Law Tribunal, Kolkata Bench and the Hon'able National Company Law Tribunal, Mumbai Bench, ("NCLT") vide their Orders dated 05.01.2024 and 23.02.2024 respectively have sanctioned Scheme of Amalgamation. BGHPL has filed the certified copy of the Hon'ble NCLT Order with the Registrar of Companies, West Bengal and Registrar of Companies, Mumbai - Maharashtra on 24.05.2024.

Shareholding of Promoter and Promoter Group includes 4.60% GDRs and Public Shareholders include 3.01% GDRs. Refer the Deposit Agreement between the Parties w.r.t. voting rights.

Voting Rights on shares are in proportion to the amount paid up on the face value of such shares.

As the shareholding pattern upload utility on the stock exchanges websites does not recognise voting rights in fractions the same have been rounded off to the nearest full figure.
