The Company has received disclosures under Regulation 7(2) of SEBI (Prohibition of Insider Trading) Regulations, 2015, from one of the Promoter Group Companies viz. Thai Rayon Public Company Limited (Thai Rayon) intimating aggregate purchase of 28,49,666 GDRs of the Company from secondary market (Luxembourg Stock Exchange) during the quarter ended 31st December 2020. Post acquisition Thai Rayon holds 47,74,666 GDRs of the Company (0.73%). The said changes are also reflected in the details of Significant Beneficial Owners and the details of registered owner in this shareholding pattern.

In terms of SEBI (Share Based Employee Benefits) Regulations, 2014, the trustees of the Grasim Employees' Welfare Trust ("Trust") do not have voting rights in respect of the shares held by the Trust. The voting rights will be available to the individuals (Option Grantees) upon exercise of the Options by them under the Company's Employee Stock Option Scheme 2018.
